Refund Policy

1. Notification Due to Non-Delivery of Course:

Selfstrology will notify the Student within three working days upon knowledge of any of the following:

- It does not complete the Course by the Course Completion Date;
- It terminates the Course before the Course Completion Date;

2. Withdrawal and Postponement:

If the Student is unable to attend more than 90% of the course duration and course dates, the student may seek to notify Selfstrology Academy with a written notice of intention of postponement or withdrawal from the course.

- **Postponement:** Defer to a later course date, with the validity of 1 year for the course deposit paid.

3. Withdrawal Due to Other Reasons:

If the Student withdraws from the Course for any reason other than those stated in Refund Policy Clause 1 above, Selfstrology Academy will, within seven working days of receiving the Student's written notice of withdrawal, process with the following conditions:

- If the withdrawal notice is more than 14 days prior to course commencement, refund will be made on any course fees paid, except the deposit which is non-refundable.
- If the withdrawal notice is less than 14 days prior to course commencement, no refund will be made and will be considered as a postponement of course commencement.

4. Course Deposits
